# Chairman's Report

### Year ending 31 March 2020

The 17th Year of our operation finished in unprecedented times courtesy of Covid-19.

We are now operating 55 venues and 827 gaming machines.

Our total funding to the Community for the year ended 31 March 2020 amounted to \$19,887,116.42, with 926 applications approved to 604 individual applicants.

Grassroots' Strategy is to return 70% of our funding to Sport and 30% to Community and Education. We take seriously our position in the market as a Community Funder and in the year to 31 March 2020, 52% of our total funding was granted to Sport and 48% granted to Community and Education.

We pride ourselves on providing significant funding to all our local communities. A snapshot of the varied nature of grant funding to local bodies, schools, sports and community groups is shown as follows:

Counties Manukau Hockey Association

Grassroots Trust funded \$150,000 toward the costs associated with resurfacing the hockey turf at Rosa Birch Park, Pukekohe.

#### Karekare Surf Lifesaving Club

Grassroots Trust funded \$200,000 toward the costs associated with the Karekare Surf Lifesaving Club Facility Development Project.

• Tokoroa Mountain Bike Club (TMBC)

Grassroots Trust funded \$113,201.06 toward the costs associated with constructing four new mountain bike tracks in Cougar Park, Tokoroa.

Kamo High School

Grassroots Trust funded \$151,000 toward the costs associated with removal and replacement of their existing turf.

#### • Te Kuiti Primary School

Grassroots Trust funded \$100,000 toward the costs associated with the installation of a new playground.

#### • The Bruce Pulman Park Trust

Grassroots Trust funded \$400,000 toward the costs associated with the development of the North East Corner at Pulman Arena on Pulman Park.

#### • Waipa District Council

Grassroots Trust funded \$200,000 toward the costs associated with the construction of a new indoor pool facility in Cambridge.

#### Rotorua Lakes Council

Grassroots Trust funded \$200,000 toward the costs associated with purchasing a removable bulkhead to be installed in the outdoor 50m pool.

Waikato Community Hospice Foundation

Grassroots Trust funded \$400,000 toward the costs associated with purchasing a property near their base to future proof the site.

#### • The Order of St John Northern Region Trust Board

Grassroots Trust funded \$68,071.30 toward the costs associated with purchasing a health shuttle to be based in Thames.

#### Various Schools

Grassroots Trust funded over \$260,000 toward information technology for schools across the communities we support.

We are particularly proud of our place in the market as the fourth largest Class 4 Operator in New Zealand.

We continue to be the first and only Society to be awarded a Best Practice Three Year Licence by the Department of Internal Affairs which was the culmination of some very hard work by our team and our Management Company, Maxserv, who continue to be Industry Leaders in everything that they do.

### Our growth strategy continues to be achieved as follows:

- We aim to be first to market with technology and innovation.
- 2. We are committed to creating a Culture of Care across all venues and take our Harm Prevention and Minimisation Programmes very seriously.
- We pride ourselves on our community engagement and have taken steps to ensure that we know the communities in which we operate. We continue to have locally based Directors in our main areas of operation.
- 4. In addition, we participate in Regional Funding Expos and have also engaged with Local Communities by organising Grant Information Evenings so that the local communities in which we operate understand what funding is available and what Applications for Funding will be likely to receive support.

Many Territorial Authorities have reviewed their

Gambling Venue Policies in the past 12 months, and more are continuing to undertake this process. Grassroots Trust has been actively engaged with these reviews to achieve the best outcomes for the Community.

The Class 4 Gaming Model receives a lot of public criticism, however in my view it is the best model for gambling in New Zealand. For every dollar that is recieved by the Grassroots Trust, 40% of that dollar is returned to the Government in the form of taxes and fees, and a minimum of 40% is returned to the community in the form of Community Grants. In other jurisdictions such as some areas in Australia, there is no requirement to return any money to the Community and, any money gambled online ends up offshore.

Balanced against these factors is the seriousness in which we treat our role in Harm Prevention and Minimisation which is not a factor that is taken into account when people gamble online.

Lastly, and most importantly I would like to thank the people that make Grassroots a strong and vibrant organisation and that is firstly our Venue Operators who are the ones that manage our gaming activities on a day to day basis and implement our strategies and Harm Prevention and Minimisation Programmes. It is a difficult job that you have, and we are grateful for your support and all the efforts that you make on our behalf.

I would also like to thank my Board who go the extra mile heavily integrating themselves in their Local Community and understanding the needs of those Communities.

My thanks is also extended to Tim Wood and his Team at Maxserv who as I have said are Industry Leaders.

I hope to be able to report in a similarly positive vein for the year ended 31 March 2021.

All the best for the forthcoming 12 months.

# The dollar

### Where does the money go?

For every \$1 spent at a gaming machine on average

For every dollar put in to a gaming machine, 91 cents on average is returned to the player in winnings. This is the highest rate of return of any form of legal gambling in New Zealand.

At least 40% of revenue generated from gaming machines and not returned to the player goes towards community initiatives in the form of grants. Every year, pub and club gaming machines return around \$300 million to the community through applications from around 13,000 groups.

The Government receives around 40% in taxes, duties and fees, and the rest goes towards administration and venue costs, and the mitigation of problem gambling.

Around \$11 million of gaming machine revenue goes to the Ministry of Health annually through the problem gambling levy for implementing their harm minimisation programme.

# Our stories

# Local funding to local communities

#### Kamo High School

The students at Kamo High School can now enjoy their new all-weather turf courts which will allow the school to offer a wider range of sports such as tennis, netball and hockey with the help of funding support from Grassroots Trust.

Kamo High School is a decile 4 Secondary School located in Kamo Village, Whangarei. As a large co-ed school, they offer a broad curriculum in a supportive learning environment. Students achieve highly and the school has gained excellent academic results over recent years.

Kamo High School encourages students to work as part of a team to develop leadership, self-management, and perseverance as well as their other school values: Tū Pono (pride), Urunga (participation), and Aroha Atu (respect).

#### Mount Maunganui Lifeguard Service Incorporated

Mount Maunganui Lifeguard Service's core purpose is to provide volunteer lifeguarding and land-based rescue services on and around Mount Main Beach, Mauao and Pilot Bay throughout peak season from Labour Weekend to Easter Weekend.

Having recently completed their new Lifeguard Centre March 2019 of which Grassroots Trust provided significant funding support, the project did not allow for the installation of a lift. More than one of their members is confined to a wheelchair and were restricted from accessing the Centre's upstairs clubrooms, were unable to accompany their young children to meetings and were unable to fully utilise the facilities as other members do. With an inclusivity strategy for their sport and lifeguard programme, the Club identified this as a significant issue, and with full financial support from Grassroots Trust of over \$80,000, the club were able to install a purpose build electric lift.

Speaking of the approved funding, Mount Maunganui Lifeguard Service's Chair, Paul Manning said,

"Our entire community is incredibly grateful and very humbled by Grassroots Trust's generosity in supporting us to build our new fit-for-purpose facility. Grassroots Trust's assistance will ensure we can continue to keep people safe at the Mount Main beach. We are also over the moon with the funding provided for a new lift for our facility, which will ensure access to our top floor for all community members. This means we are truly a club catering for all aspects of our local community. This would not be possible without Grassroots Trust's help and support."



#### Karekare Surf Lifesaving Club

The Karekare Surf Lifesaving Club provides volunteer lifesaving and emergency services at Karekare Beach and the seven kilometres of coastline south to Whatipu on the Manukau Heads.

Karekare is consistently regarded as one of New Zealand's best beaches and is a location that the majority of Aucklanders visit. Despite its beautiful reputation, Karekare is also one of the most dangerous beaches in the country, known to have strong rip currents, so a lifesaving service is essential to keep beach users safe and provides immense benefit to all who visit.

In 2010 the Club started making plans to replace their current and outdated lifesaving facility due to failing structural issues. Built in 1956, the facility configuration does not meet the needs of a modern lifesaving service nor have the equipment required to deliver it. While the main goal in the design of their new facility was to meet their lifesaving needs, an additional factor is to provide a community facility for use by the local community and wider Auckland groups.

After 15 years of planning and with \$200,000 funding from Grassroots Trust, the new building has now commenced and is on target to be completed in April 2021.

Speaking of the approved funding, Club Chairman Andy Shaw said, "The Club is delighted that this new \$3.3m rebuild will serve future generations of lifesavers on this beautiful but often dangerous west coast beach. It has been a long process raising the funds for the building designed by local architect, Richard Priest. The club acknowledges all our funders, particularly Grassroots Trust whose funding has enabled this project to get underway. It is a major rebuild for the club which is celebrating 85 years on the beach and has over 100 young and experienced lifeguards, many who have been raised in the local community."

Club President, Sir Bob Harvey said, "This is such a special event for the Karekare beach area and our local community. This wonderful new asset will last us through the century ahead, it will be a state-of-the-art lifeguarding hub and community resource centre for all to share."

#### Waipa District Council

Waipa District Council is a territorial local authority constituted under the Local Government Act 2002. Recently Grassroots Trust funded \$200,000 toward the costs associated with the construction of a new indoor pool facility in Cambridge.

The facility will incorporate the refurbishment of the existing 50m outdoor pool and the construction of a 10-lane 25m indoor pool, junior pool, hydrotherapy pool, Learn to Swim pool, spa and sauna. The planned upgrades and new additions to the Cambridge Community Pool will radically improve the existing and aged facility. The outcomes will be increased participation in physical activity, skill development and social cohesion - all strengthening the Waipa community.

Speaking of the approved funding, Gary Knighton, Manager Strategic Partnerships at Waipa District Council said, "The new pool facility is an exciting and long awaited project for Cambridge. It will provide recreational and play opportunities for a wide range of the community, across all age groups and the generous contribution from Grassroots Trust was an important stepping-stone to getting the project completed."

#### **Tamatea Primary School**

The students of Tamatea Primary School are enjoying and benefiting from 75 Chromebooks and 40 iPads, made available through the generous funding support of Grassroots Trust of over \$45,000.

Tamatea Primary School is a decile 3 full Primary School with a diverse roll of between 180 and 215 students, most of which are of Māori and Pacific descent and a range of other ethnic groups.

The school is underpinned by MANA values of Mahi Tahi, Ako, Ngākau Pono and Āwhina. The school's definition of Ako is to learn collaboration, digital literacy and problem solving.

IT and digital media competence are important skills for our children to develop, especially as we live in a world where these skills are needed in the workplace. Digital technologies can have many positive impacts on learning and offer challenging activities and opportunities for real world problem-solving activities.

Digital technology is an increasingly important part of the learning programme for students at all levels. Portable digital technology allows students to access the internet and to use a variety of digital applications to support their learning, as and when it is appropriate.

Grassroots Trust Chairman, Martin Bradley said,

"Grassroots Trust aims to provide grants to communities where the funds were generated. We're very proud to support our local schools to ensure students are able to fully participate in digital learning opportunities at school."

#### **Te Kuiti Primary School**

## Te Kuiti Primary School is a decile 3 full Primary School with a current roll of 329 students.

Grassroots Trust recently funded \$100,000 toward the costs associated with the installation of a new playground. The existing playground was in the vicinity of 30 years old and in dire need of upgrading. The playground is used by students daily and is accessible to the wider community after hours and on the weekends.

Speaking of the approved funding, Te Kuiti Primary School Principal, Melissa Anderton said,

"The Board of Trustees and community would like to thank Grassroots Trust for their kind donation towards our new playground. This has been a long awaited project that we are thrilled to have installed in our school. This playground is important to our school as it means the children have opportunities to be active and gain self-confidence when they master an activity that was previously challenging. It also supports the development of cognitive learning, physical development, and social growth. This new playground provides a free activity for our families and has already proven to be getting a lot of use on the weekends. We are pleased to have this amazing playground that is going to be enjoyed by many students and whanau over the coming years."

#### **BASIS OF PREPARATION**

1. These summary financial statements are for Grassroots Trust Limited for the year ended 31 March 2020.

The summary financial statements are presented in New Zealand Dollars (NZD) and rounded to the nearest dollar.

These summary financial statements are for Grassroots Trust Limited for the 12 months ended 31 March 2020. The comparative figures are also for a 12 month period.

The full financial statements comply with Public Benefit Entity Accounting Standards and other applicable Financial Reporting Standards, as appropriate for Tier 1 non-for-profit public benefit entities.

The summary financial statements are presented in summary form and therefore do not give all the information required by PBE Standards. Disclosures included in the summary financial statements have been extracted from the full financial statements and no information has been restated or reclassified.

Because of their summarised nature, these summary financial statements cannot provide a full understanding
of the financial performance, financial position and cash flows of Grassroots Trust Limited.
The understanding can only be obtained by reference to the annual financial statements of Grassroots Trust Limited.

The full financial statements for the year ended 31 March 2020 were authorised on 10th September 2020 by the Directors.

#### 6. Borrowings

The borrowing consists of 16 separate BNZ loans financed for 36 months with maturity dates August 2020 to March 2023. The interest rates are 6.61% to 7.46% (2019: 17 loans, 7.61% to 7.92%). Finance is secured over all present and after acquired property of Grassroots Trust Limited.

7. As at reporting date there were no grants approved by the Directors but not disbursed. (2019: Nil).

The Company has agreed to purchase \$451,131 of gaming machines and equipment. There are no other commitments at balance date. (2019: \$659,271).

- 8. At reporting date there are no known contingent liabilities. (2019: Nil)
- 9. During March 2020, a global pandemic called COVID-19 was declared by the World Health Organization. In response, New Zealand went into Level 4 lockdown, imposing restrictions on trading operations. On 25 March 2020 all trading operations in venues were ceased. Level 2 lockdown restrictions were implemented on 13 May 2020 allowing all trading operations in venues to commence.

A second wave of COVID-19 restrictions was declared by the Government and Auckland went into Level 3 restrictions on 12 August until 30 August whereby 16 Auckland based venues were closed and trading operations ceased.

During the first lockdown period, the Company's revenue was reduced to zero. Over the 2 weeks of the second partial lockdown the Company has had a 20% reduction in revenue. The New Zealand Government offered a subsidy to businesses having a significant reduction in revenue. The Company applied, received and spent the full subsidy for its one employee. Many expenses were reduced due to having no revenue including gaming machine duty and venue commissions.

In response to COVID-19 the Government introduced Gambling (Class 4 Net Proceeds) Amendment Regulations 2020 to amend the Gambling (Class 4 Net Proceeds) Regulations 2004 Act. The amendment removed regulation 10(4) which was the requirement to distribute a minimum of 40% of gross proceeds and regulation 11(2) relating to the timing of distributions to the community. In addition, a Society may retain net proceeds to build sufficient cash up to a working capital ratio of 1.5 to 1.

There may well be additional impact from COVID-19 however, it is estimated that the impact will not jeopardize the continuity of operations, as well as the financial commitments assumed.

There are no other material subsequent events which required recognition or additional disclosure in these financial statements.
