Chairman's Report

Year ending
31 March 2024



Like most sectors of the community the past 12 months have provided challenging economic conditions although we are proud to have returned 42.41% to the community.

The past 12 months have seen our venue numbers remain constant with some changes in operators.

In the main revenue has been flat.

Return to Community

Pursuant to the provisions of the Gambling Act 2003 Grassroots Trust is required to return 40% of net proceeds to the community. Grassroots Trust are proud that we were able to return 42.41%

Total grants for the year amounted to \$29,244,083.15

This is compared to our year end for 2023 being turnover of \$68,077.726 and return to community of \$29,590,979.

During the year ended 31 March 2024, 63% of our total funding was granted to Sport, 18% to Community & Arts and Culture, 12% to Research & Education, and 6% to Health & Welfare.

Our Return to Community was only possible due to the quality of our Venue Operators and the hard work of our Management Contractor, Maxserv, and Suppliers. I thank you all for your support.

Our number one strategic priority is Harm Prevention and Minimisation.

Harm Minimisation

The Gambling (Harm Prevention and Minimisation) Amendment Regulations 2023 were enacted by the outgoing government and has resulted in higher standards of harm minimisation being required across the sector. Although there is no doubt that there is always room for improvement, these Regulations are detracting from existing harm minimisation programmes rather than adding to them in a positive way. As an industry we strive to have the best harm minimisation programmes, however the new Regulations have seen a backward step with a number of unintended consequences.

These Regulations are the subject of pending court applications however the court process is unlikely to be concluded until mid-2025.

We pride ourselves on the standard of our Harm Minimisation programme and training, however we constantly try to improve. We also regularly review all policies under which we operate as we strive toward excellence in everything we do.

Grassroots Trust has commenced the implementation of a Facial Recognition rollout so that all problem gamblers can be identified when they enter a venue and are excluded. We see this as an industry leading approach.

We monitor breaches by excluded players on a monthly basis, and we are pleased to report that the technology is working, however there is still a significant portion of excluded players identified by venue staff which gives us confidence that our Harm Minimisation training is of the highest standard.

The recently implemented regulation changes mean that the community can have confidence that the industry is taking their Harm Minimisation role seriously.

Grants

It is important that the funds that are distributed are to the areas in which they were generated. We are stringent in adhering to this strategy. A snapshot of the very nature of our funding be they schools, sporting groups, or other community groups is shown as follows:



- **The Order of St John Northern Region Trust Board**
Grassroots Trust funded \$659,541.92 toward purchasing a Major Incident Support Vehicle, two Gen 4.1 Ambulances for the Auckland Region and a Meduvent ventilator.
- **Waka Pacific Trust**
Grassroots Trust funded \$400,000.00 toward the construction expenses for New Zealand's largest climbing structure at the Vector Wero Whitewater Park.
- **Tauranga City Council**
Grassroots Trust funded \$250,000.00 toward the construction of a skatepark (zones three and four) in Mount Maunganui.
- **Waikato Diocesan School for Girls**
Grassroots Trust funded \$250,000.00 toward resurfacing the hockey turf.
- **Waikato Regional Property Trust Board**
Grassroots Trust funded \$250,000.00 toward supplying and delivering the precast concrete panels to the Flytower for the Waikato Regional Theatre.
- **Waitomo District Council**
Grassroots Trust funded \$250,000.00 toward refurbishing the Centennial Park Grandstand.
- **Rugby for Life Charitable Trust**
Grassroots Trust funded \$236,666.67 toward multiple salary expenses.
- **The Sir John Kirwan Foundation Board**
Grassroots Trust funded \$179,082.00 toward coaching salary expenses.

For every dollar put in to a gaming machine, 91 cents on average is returned to the player in winnings. This is the highest rate of return of any form of legal gambling in New Zealand.

At least 40% of revenue generated from gaming machines and not returned to the player goes towards community initiatives in the form of grants. Every year, pub and club gaming machines return around \$300 million to the community through applications from around 13,000 groups.

The Government receives around 40% in taxes, duties and fees, and the rest goes towards administration and venue costs, and the mitigation of problem gambling.

Around \$11 million of gaming machine revenue goes to the Ministry of Health annually through the problem gambling levy for implementing their harm minimisation programme.

Authorised purpose

Grassroots Trust Limited is licensed to operate gaming machines to raise money for the following authorised purposes:

A Amateur sport.

B Any charitable purpose.

C Any non-commercial purpose that is beneficial to the whole or a section of the community.



The authorised purposes include, but are not limited to, applications for the promotion and development of:

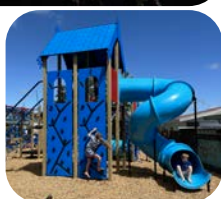
- Amateur sport through direct support of sporting bodies. Grants will only be granted to sports bodies which are formally established and legally constituted.
- Community organisations which are established for charitable, educational, or cultural purposes beneficial to the community or a section of it or any other purpose beneficial to the community or a section of it.

Grants will not be made for the purpose of stake money for any types of races.

With the exception of grants to national societies or agencies, funds are mainly distributed within the local community in which they are raised.

No payment, commission, or any other kind of reward, financial or otherwise, can be attached or demanded as a precondition for the payment of a grant.

Authorised purposes must benefit the community and not result in commercial or personal gain.



Our Stories

Local funding to local communities

Tauranga City Council

When it comes to external funding, Tauranga City Council's Destination Skatepark at Mount Maunganui has been a real collaborative effort.

The funding received has allowed for the development of two additional zones, which are specifically designed for developing basic and intermediate roller skills. This has made the skatepark more inclusive and accessible, thus creating healthier communities and enhancing the wellbeing of our rangatahi.

Grassroots Trust provided funding of \$250,000.00 toward the construction of a skate park (zones three and four) in Mount Maunganui. With this funding Destination Skate Park enhances the communities physical, social and mental wellbeing. Along with creating a fun, unstructured, affordable activity that promotes being active and creative in suitable outdoor environments.



Anne Blakeway, Manager: City Partnerships, Tauranga City Council said, "Partnership is the ethos of how we work with our funders. We value the collaborative nature of our relationship with Grassroots Trust. We have also valued the guidance from Martin and his Board.

The funding received for the Destination Skatepark project in Mount Maunganui has elevated the community facility to a national level. We look forward to many more years of partnership with Grassroots Trust."



Rugby for Life Charitable Trust

Rugby for Life aims to develop people and communities, embrace positive change, and nurture pride within the people of Northland.

Dedicated to promoting the values of teamwork, inclusivity, and personal development through rugby communities at the grassroots level. Their programmes provide opportunities to learn, grow, connect and thrive both on and off the field.

Grassroots Trust provided funding of \$236,666.67 towards the operational costs of numerous salary expenses within the Organisation. Vital for ensuring the smooth operation and effectiveness of Rugby for Life's programmes and initiatives. Along with the major component in the delivery of leading social and economic change within the community.

Ajit Balsingham, Chairman said, "Grassroots Trust funding has allowed us the ability to see our vision of harnessing the power of rugby to create socio-economic change in our Northland communities. Being able to place Rugby for Life coordinators in our partner rugby clubs means that our bottom-up approach to overcoming nuanced and different issues across a large geographical area continues to be successful in its positive impact for our people. Most importantly Grassroots Trust understands and embraces the challenges faced by our everyday rugby community".

Kids in Need Waikato Charitable Trust

Kids in Need Waikato supplies care packs for children in foster care, grandchildren being raised by grandparents, or any child being cared for by someone other than their biological parents.

Help can come in all shapes and sizes, and for Kids in Need Waikato, they needed a bit of help to buy a ute. After 3 years of leasing, Grassroots Trust provided funding of \$57,240.00 which enabled them to buy a brand-new ute. This helped them with their travels all over the region, where they drop off personalised care packs for children being cared for in a foster family situation.



Linda Roil, Founder said, "Being able to purchase a new vehicle was such a game changer for Kids in Need, thanks to Grassroots Trust's generous grant. This has enabled us to extend our reach in the community through educating more people about the important work we do for vulnerable children and their caregivers, which in turn has led to greater contributions towards our programmes..

Our wellbeing programmes are aiding social connections for the families we support; an extension of our care packs service that we've been providing for the past six years.

Bombay Junior Rugby Football Club Incorporated

Bombay Junior Rugby Football Club are a relatively small, rural junior rugby club based in Bombay, South Auckland. With steady growth, the club ranges from 320 – 350 children for the 2024 season.

Grassroots Trust provided funding of \$18,200.00 towards purchasing playing jerseys to replace their current uniforms that have seen four years' worth of rugby. With the cost of living, often causing a barrier to play, this funding enabled the children to have an accessible presentable uniform to play.

Dan Bailey, Secretary said, "With the support of the Grassroots Trust, the Bombay Junior Rugby Club has been able to provide new playing jerseys for our Junior Club. Our club has grown to nearly 300 kids with 24 teams across all grades. Being able to keep our fees at a constant level has been key to the continued growth the club is seeing.

Without the support of the Grassroots Trust, we may have had to increase our fees to cover those costs, which could provide barriers for kids to play the sport they love.

Our objective is to foster and encourage kids to be active and healthy by having fun in rugby both on and off the field, the help we get from Grassroots Trust allows us to continue with this".
