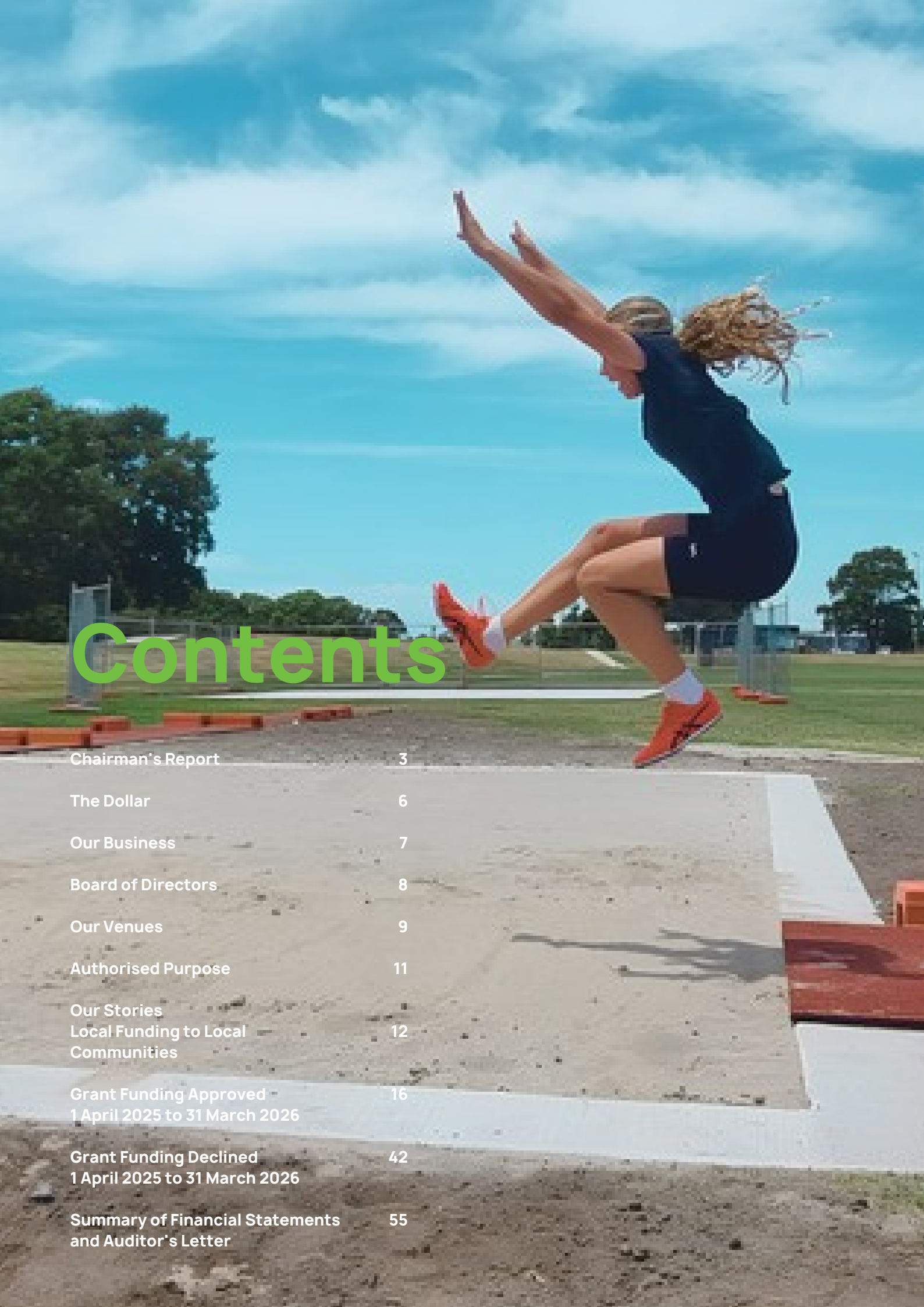

Chairman's Report

Year ending
31 March 2026



Like most sectors of the community, the past 12 months have provided challenging economic conditions, although we are proud to have returned 40.85% to the community.

The past 12 months have seen our venue numbers remain relatively constant with some strategic growth with high performing venues across the country.

In the first part of the year, revenue remained flat, however we have seen stronger revenue in the past six months.

Return to Community

Pursuant to the provisions of the Gambling Act 2003, Grassroots Trust is required to return 40% of net proceeds to the community. Given the economic conditions, Grassroots Trust are proud that we were able to return 40.85% (down from 42.41% in 2024 and 41.37% in 2025).

Total turnover was \$67,142,611.00 and grants for the year amounted to \$27,652,506.04.

This is compared to our year end for 2025 being turnover of \$66,800,532.00 and return to community of \$27,779,274.87, and for 2024, a turnover of \$69,688,340.00 and return to community of \$29,244,083.15.

During the year ended 31 March 2026, 64% of our total funding was granted to Sport, 20% to Community & Arts and Culture, 6% to Research & Education, and 6% to Health & Welfare.

Our Return to Community was only possible due to the quality of our Venue Operators and the hard work of our Management Contractor, Maxserv, and Suppliers. I thank you all for your support.

Harm Minimisation

Our number one strategic priority is Harm Prevention and Minimisation.

The Gambling (Harm Prevention and Minimisation) Amendment Regulations 2023 have now been in force for two years and has resulted in a higher standard of harm minimisation practices occurring across the sector.

The Department of Internal Affairs has worked with the sector to ensure compliance which has certainly assisted.

Grassroots Trust has continued the implementation of the Facial Recognition rollout so that all problem gamblers can be identified when they enter a venue and are excluded. We see this as an industry leading approach. Grassroots Trust now has facial recognition technology operating across 88% of venues.

One significant advance during the past financial year has been the creation of the MyChoice App, which is a self-exclusion harm minimisation tool enabling problem gamblers to exclude themselves from the comfort of their home and by the use of their mobile phone. The App can also direct the problem gambler to the appropriate authorities for assistance. We are very proud of this development and a number of our competitors are embracing the technology.

We pride ourselves on the standard of our Harm Minimisation programme and training.

However, we constantly try to improve. We also regularly review all policies under which we operate as we strive toward excellence in everything we do.

The recent development of the MyChoice App by Grassroots Trust means that the community can have confidence that the industry is taking its harm minimisation role seriously.

Grants

It is important that the funds that are distributed are to the areas in which they were generated. To this end, we have conducted a number of Regional Grants Evenings around the country, explaining to local sports and community groups what we have to offer and to convey our funding priorities. These events have been very well received. We are stringent in adhering to this strategy. A snapshot of the very nature of our funding recipients, be they schools, sporting groups, or other community groups, is shown as follows:

- **The Bruce Pulman Park Trust**
Grassroots Trust funded \$393,931.42 to support operations and key infrastructure improvements, including field maintenance equipment, civil works to enhance Eastern Park access, and the installation of a new arena scoreboard.
- **The Order of St John - Central Region Trust Board & Northern Region Trust Board**
Grassroots Trust funded \$578,298.56 to support essential emergency services, including funding for new ambulances in Hamilton, Cambridge, and Whangarei, enhancing frontline response capability across multiple regions.
- **Highbrook Regional Watersports Centre Trust**
Grassroots Trust funded \$325,000.00 toward the construction of a new watersports clubhouse facility at Highbrook in East Tamaki, supporting the development of regional sport and recreation infrastructure.
- **New Zealand Sikh Community Tauranga Trust**
Grassroots Trust funded \$302,500.00 toward scaffolding costs associated with the construction of a new temple, supporting the development of a key community and cultural facility.
- **Rugby For Life Charitable Trust**
Grassroots Trust funded \$269,999.95 toward wages for staff delivering community programmes across the Far North, Whangarei, and Kaipara districts.
- **Kaipara Cycling Incorporated**
Grassroots Trust funded \$220,000.00 toward the development of a new pump track, supporting active recreation and community wellbeing in the Kaipara District.
- **The Sir John Kirwan Foundation Board**
Grassroots Trust funded \$174,000.00 toward operational expenses and coaching staff salaries, supporting mental wellbeing programmes for young people across Auckland and Waikato regions.

- **The Kids In Need Waikato Charitable Trust**

Grassroots Trust funded \$114,403.84 toward essential staff salaries, supporting the organisation's ability to maintain services and operational continuity for families in need.

- **Kihikihi Rugby Sports Club Incorporated**

Grassroots Trust funded \$95,787.00 toward clubroom upgrades and facility improvements, including repairs, landscaping, and storage enhancements, as well as purchasing new uniforms and equipment for netball and rugby teams.

Our Team

None of this would be possible without the excellent team that makes Grassroots Trust a strong and vibrant organisation.

Firstly, our Venue Operators are the ones that manage our gaming activities on a day-to-day basis and are responsible for implementing our Harm Prevention & Minimisation programmes. It is a difficult job you have in this space, and we are grateful for the support and all the effort you make on our behalf.

Tim Wood, Aaron Lawton and their team at Maxserv provide our management support; they are industry leaders and are a significant reason for the success Grassroots Trust has achieved in recent times.

I also extend my thanks to my Board who treat their function as community funders incredibly seriously. The level of integration we have in our local communities also forms part of Grassroots Trust's ongoing success.

Looking Forward

Grassroots Trust looks forward to the coming year from a sound base of growth and excellence in the hope that the upward trend of our operations over recent years continues. In my last year's report, I touched on the advent of Online Gambling and the issue of 15 Online Gambling Licenses which is charted to occur in December 2026.

The impact this will have on our charitable model cannot be accurately determined until the draft regulations are released and finalized. The central issue will be whether the regulations are fair to the Class 4 sector. There are various examples around the world where governments have got this wrong and have led to a cannibalisation of land-based gambling. There are other examples, however, where land-based gambling has increased with the advent of online gambling. The next 12 - 24 months will be an interesting space for community funding however we do not anticipate revenue being overly impacted although it is reasonable to assume there will be some impact.

For every dollar put in to a gaming machine, 91 cents on average is returned to the player in winnings. This is the highest rate of return of any form of legal gambling in New Zealand.

At least 40% of revenue generated from gaming machines and not returned to the player goes towards community initiatives in the form of grants. Every year, pub and club gaming machines return around \$300 million to the community through applications from around 13,000 groups.

The Government receives around 40% in taxes, duties and fees, and the rest goes towards administration and venue costs, and the mitigation of problem gambling.

Around \$11 million of gaming machine revenue goes to the Ministry of Health annually through the problem gambling levy for implementing their harm minimisation programme.

Authorised purpose

Grassroots Trust Limited is licensed to operate gaming machines to raise money for the following authorised purposes:

A. Amateur sport.

B. Any charitable purpose.

C. Any non-commercial purpose that is beneficial to the whole or a section of the community.



The above authorised purposes include, but are not limited to, applications for the promotion and development of:

- Amateur sport through direct support of sporting bodies. Grants will only be granted to sports bodies which are formally established and legally constituted.
- Community organisations which are established for charitable, educational, or cultural purposes beneficial to the community or a section of it or any other purpose beneficial to the community or a section of it.

Grants will not be made for the purpose of stake money for any types of races.

With the exception of grants to national societies or agencies, funds are mainly distributed within the local community in which they are raised.

No payment, commission, or any other kind of reward, financial or otherwise, can be attached or demanded as a precondition for the payment of a grant.

Authorised purposes must benefit the community and not result in commercial or personal gain.



Our Stories

Local funding to local communities

Kaipara Cycling Incorporated

Kaipara Cycling is a community-focused, volunteer-led organisation creating safe, inclusive, and accessible opportunities for cycling and wheeled sports across the Kaipara district.

The group's work responds to a clear community need for outdoor recreation spaces that support healthy lifestyles, skill development, and participation for people of all ages and abilities. In 2020, Kaipara Cycling opened Pou tu o Te Rangi Mountain Bike Park at Harding Park in Dargaville, creating four downhill tracks and one uphill track for everyone from young beginners to experienced riders. The group has also taken on restoration projects, including clearing Old Mill Road at Donnelly's Crossing and working with locals to reopen a former council road for recreational cycling. Its close work with schools and Kaipara District Council helps ensure each project delivers lasting benefits for the wider community.



Grassroots Trust provided \$220,000.00 toward costs associated with building the pump track, supporting Kaipara Cycling's mission to create lasting cycling opportunities and active recreation benefits for the Kaipara District community.



"Kaipara Cycling have been developing Harding Park for a number of years. The Park is located 2kms from the centre of Dargaville which means it is easily accessible by bike to the Park. Groups of friends can be seen heading to the park after school and after work on their bikes. The Park currently has 5 trails that weave down the hill with different levels of skill needed to negotiate the trail and features. There is one gradual uphill to the top where the public bbq area is located. The park is used by all ages as it is a great practice area for beginners and experts alike. The latest funding from Grassroots Trust has enabled Kaipara Cycling to include a professionally built all weather pump track, again targeting beginners and experts alike to hone their skills. This pump track to be built by Velosolutions will fill a large unused area of the park and create another area for locals and visitors on bikes. The local cluster of primary schools share a fleet of bikes that will also be able to spend time lapping the pump track. A perfect addition to Harding Park and Dargaville." The Sir John Kirwan Foundation



The Sir John Kirwan Foundation supports the wellbeing of young people through Mitey, a preventative mental health education programme that enables schools to embed health and wellbeing into everyday teaching and school culture.

The demand for the programme continues to grow throughout New Zealand, with more schools seeking practical and sustainable approaches to supporting student mental health. Mitey coaches work directly with each school to tailor to its community, provide ongoing teacher mentoring, and foster a shared language around wellbeing for teachers, students, and families. In 2025, the Foundation expanded from 190 to 271 schools, reaching an additional 24,632 children bringing the total number of children benefiting from the programme to 90,960, alongside 4,134 teachers nationwide.

Grassroots Trust provided \$174,000.00 toward operational expenses and coaching staff salaries, helping schools build long-term wellbeing capability and supporting better mental health outcomes for young people across the country.

Hamilton Old Boys Rugby and Sports Club

Founded in 1916, Hamilton Old Boys Rugby and Sports Club Incorporated is one of the oldest and most successful clubs in the Waikato region.

The club plays an important role in bringing people together through sport. From junior players taking their first steps onto the field to senior members, families, supporters, and volunteers, it provides a welcoming environment for training, connection, and community participation.

Maintaining consistent, year-round training has historically been a challenge, with Hamilton receiving almost 1.2 metres of rainfall annually, impacting the condition and usability of outdoor fields. To address this, the club has installed a state-of-the-art artificial turf surface, ensuring rugby can be played year-round. This upgrade provides a reliable, safe, and durable playing surface that supports player development, encourages participation across all age groups, and enhances the club's ability to host games and training regardless of weather conditions. The investment will future-proof the club's facilities, ensuring ongoing access to quality rugby for the community.

Grassroots Trust provided \$549,789.00 toward these essential facility upgrades and operational costs enabling Hamilton Old Boys Rugby and Sports Club to continue to thrive.



New Zealand Sikh Community Tauranga Trust

Welcoming people from all walks of life, this Tauranga-based spiritual and cultural hub, run by the New Zealand Sikh Community Trust, serves an estimated 10,000 residents across the Bay of Plenty.

The temple plays a central role in community life, embodying the Sikh principles of unity, service, and compassion while welcoming people from all backgrounds, castes, and creeds without discrimination. Through Langar – a free community kitchen serving vegetarian meals to anyone in need throughout the week – the temple provides practical support for migrants, families experiencing hardship, and anyone seeking a warm meal and a sense of belonging. It is also a focal point for major community celebrations, including the annual Nagar Kirtan parade through Tauranga streets, which shares Sikh values of selfless service, equality, and unity with the wider public.

With the existing facility more than 25 years old and the growing congregation needing additional space, the Trust is expanding into a larger facility so this vital community work can continue and grow. **Grassroots Trust provided \$302,500 of funding that enabled the purchase of structural steel required for the renovation of the new temple.** With all steelworks now completed, the community is one step closer to a larger, safer, and more accessible place of worship and support for all people across Tauranga and the Bay of Plenty.

Highbrook Regional Watersports Centre Trust

Highbrook Regional Watersports Centre Trust has been established to develop and operate a subregional watersports facility at Highbrook in East Tamaki, Auckland. The facility will provide a long-term home for regional sport and recreation in South and East Auckland.

The need for this facility has been clear, Local user groups require reliable, fit-for-purpose infrastructure that supports participation, training, and future growth. With building consent secured and construction underway, the project is progressing quickly.



Murdoch Dryden, Board Chair acknowledged the importance of the project and support received "On behalf of the Board of Trustees I acknowledge our sincere thanks to the funders and supporters of this significant project which will bring significant long term positive benefits to the South and East Auckland Community."



Grassroots Trust provided \$325,000.00 toward the construction of the clubhouse, helping unlock a total project fund of more than \$5 million, supporting a facility that will deliver lasting benefits to the community.



Otago Rugby Football Union Incorporated

Established in 1881, Otago Rugby Football Union Incorporated (ORFU) is the official governing body for rugby union across the Otago region.

ORFU's purpose is to grow and foster community rugby throughout Otago and enable local pathways to higher performance. This is achieved by providing opportunities for children and adults to participate in rugby through community rugby competitions and representative teams. ORFU also delivers development and support programmes for coaches, referees, club volunteers and players.

The Otago province is one of the largest in the country and the ORFU assists the 56 Clubs and Secondary Schools located in all parts of the province to provide rugby opportunities to their members.

Rugby in Otago has a proud history and continues to play an important role in bringing communities together.

Key outcomes of this funding have included the delivery of Otago Club Connect Sessions, which have strengthened relationships and shared learning across our clubs, as well as the provision of valuable coaching support to help build capability and confidence within our rugby community. Grassroots Trust's funding plays an important role in strengthening the game at a grassroots level and ensuring that rugby continues to bring communities together across the Otago region."

Grassroots Trust provided \$152,903.84 toward various operational and salary expenses, supporting rugby participation, development, and community connection across the Otago region.
